

- FY2023 PERG Grant
 - Per TG this grant was closed in December, 2024 can be removed
- Hazmat Books Arrived
- **Keystone Cement** (6/12 6/15)
 - Per TW, Keystone Cement renewed their permit with DEP and our agency received a copy of permit on May 7, 2025. Keystone Cement is looking to shift their hazardous waste transportation from truck to rail (train). Currently awaiting any new plans or updates to plans which would cover this potential change. Also contacted Norfolk Southern representative about getting information about the tracks to be used such as speed restrictions, car count per day approx., and Norfolk Southern plans during a response to an incident at Keystone Cement, if there ever was one.
 - MRi stated that East Allen Township is still waiting for the Site Improvement Plan from Keystone Cement also.

X. New Business (provided by MRi)

- 2025-2026 HMRF Grant award of \$10,383.00

 - MRi wanted to share the HMRF previous year award chart to show the substantial decrease in funding in the last 5 years.
- HMEP Per MRi, Nothing at this time.
- 2026 IAFC Baltimore Hazmat Conference Registration Deadline May 1, 2026.
 - Per MRi, wanted to advise those in attendance today that the DEADLINE to submit interest and information for the 2026 IAFC Baltimore HazMat conference will be May 1, 2026. This allows him to register everyone on discounted rates and allows opportunity to get rooms for attendees.
- Request for up to \$10,000 for Hazmat Training
 - TW share that with the previous HMEP funds awarded a total of 6 hazmat related courses were completed costing approx. \$10,750 dollars. With the LEPC funds provided (\$10,000) a total of 5 hazmat related courses have been scheduled/completed. With those trainings held and funds spent down there is still a need to hold more hazardous materials training courses for the remainder of 2025.
 - TW is asking for \$6,500 up to \$10,000 more dollars from the LEPC funds to fund the necessary hazardous materials training courses for remainder of 2025.
 - JB inquired if TW was looking for support for this endeavor at this time. TW said it would be helpful. JB made a motion to approve the spending of up to \$10,000 in LEPC funds (above the already provided dollars) to be able to fund the necessary hazardous materials training courses during remainder of 2025. This was 2nd by NB, all were in favor.

• RAD Equipment replacement

- MR states that when our RAD equipment was at the New Jersey State Police testing location a few weeks ago for calibration and inspection it was realized that 2 of the Ludlum 26 "pancake" type meters we possess failed testing and shall be replaced.
- MR stated that each meter costs approx. \$1,500 dollars to replace, so approx. \$3,000 in total to replace both. MR did not have an updated quote to share exact costs. MR stated he was looking for support to fund the purchase of two new Ludlum 26 meters.
 - TW made a motion to approve the spending necessary to purchase 2 new Ludlum 26 meters, without the \$3,000 cap. 2nd by JB, all in favor.
