Municipal Profile

Lower Saucon Township is a rural township located in the southern part of Northampton County, on the border with Bucks County. It encompasses an area of approximately 24.3 square miles, and has a population of 11,094 (2020 Census). The township is bordered by the City of Bethlehem to the north and northwest; Hellertown Borough (which is nearly surrounded by the township); Freemansburg Borough to the northwest; Bethlehem Township to the north; Easton to the northeast; Williams Township to the east; Durham Township and Springfield Township, both in Bucks County, to the south; Upper Saucon Township (Lehigh County) to the southwest; Salisbury Township (Lehigh County) to the west; and Fountain Hill (Lehigh County) to the northwest.

The Lehigh River forms the township's northern border with Bethlehem Township.

Interstate 78 passes east-west through the eastern and western parts of the township around Hellertown. Major north-south roads through the township include PA Route 378 in the western part of the township, PA Route 412 in the south-central part of the township, the PA Route 33 interchange in the northeastern corner, and Lower Saucon Road in the eastern part of the township.
